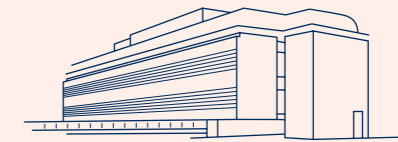


# Map of the Porto Campus

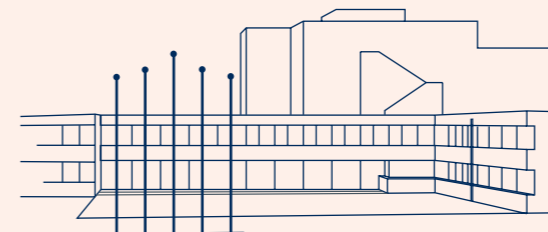

- The **approval** in the subjects of the Compulsory Core Courses and Mandatory Specific Courses and Optional Courses of the Católica Porto Business School is required, or the **crediting** of subjects with equivalent contents done outside the Católica Porto Business School. (In a previous course, international mobility, or as an external student to complete the degree).
- In international mobility context it is possible to substitute a maximum of 3 courses — 18 ECTS — by others from the same scientific area of the student's degree, subject to previous authorization of **study plan** and/or **formal request**.
- The approval to Free Elective Courses of Católica Porto Business School is required, **crediting** of subjects with equivalent contents done outside the Católica Porto Business School (in a previous course, international mobility, or as an external student to complete the degree), or the crediting of other subjects of economics, management, or other scientific areas, in Undergraduate Degrees of Católica Porto or any other School in the country or abroad, subject to authorization of **study plan** and/or **formal request**.
- Spreadsheet and Word Processing**—it is required to pass the Diagnosis Test of Católica Porto Business School or one of the short-term computer courses of Católica Porto Business School.

**English level B2**—you need to present an official B2 level diploma (CEFR) or a diploma recognised as equivalent. You can also take a standardised English language test at the Campus of Universidade Católica Portuguesa in Porto, carried out by ih-International House, or complete courses at this or other language schools.

**Christianity, Cultures and Organizations** — it is required the approval of the additional curricular unity from Católica Porto Business School.

# Frequently Asked Questions about the Study Plan

## Do you have questions about the courses? This guide is for you.

For those starting university, a new cycle is about to begin. They are bound to have many questions and queries. The aim of this guide is to help you find the answers you need to make your life at university simple.



### Which courses in my undergraduate degree's study plan must I complete at Católica Porto Business School?

You must complete a minimum of 90 ECTS credits at Católica Porto Business School, including common core courses, specific courses in the areas of management and economics and free electives. Additionally, you must complete instrumental curricular requirements like Spreadsheet, Word Processing and Christianity, Cultures and Organisations, the additional curricular unit, for which no ECTS credits are awarded. Students who do not have an official diploma in English, level B2 (CEFR), or a diploma recognised as equivalent, to fulfil the instrumental English course requirement, can complete it in other ways, namely by taking a standardised English language test, to be carried out on the Campus of Universidade Católica Portuguesa in Porto, by ih-International House, or by completing courses at this or other Language Schools.

### Can I submit a request to change from Economics to Management or vice-versa at any time?

Yes, the change of degree is always guaranteed. Your request for a change of degree must be submitted to the Board of Directors. If the request is submitted before the 1st year is over, you will be able to count 100% of the courses as having been completed in the undergraduate degree you have initially registered for, since the 1st year is common to both undergraduate degrees. If your request is submitted at a later stage, it might not be possible to count 100% of the courses as completed.

### Can I attend courses offered at Católica Porto Business School that are not part of my undergraduate degree's programme?

Yes, as free electives - 12 ECTS. If you are an Economics student you can take specific Management subjects taught in the 5th and 6th semesters of the undergraduate degree in Management, with the exception of International Management. Financial Accounting II, which are taught in the 3rd semester, and Organisational Behaviour, which is taught in the 4th semester, are also eligible. If you are a Management student you can complete the specific courses of Economics taught in the 5th and 6th semesters of the undergraduate degree in Economics and the Macroeconomics II course, taught in the 3rd semester.

### Can my study plan include courses other than those offered at Católica Porto Business School?

Yes. You can also earn 12 ECTS credits in free electives in the scientific areas of Economics / Management, or others that are offered in the different Faculties of Católica Porto, and in Universities in Portugal or abroad. Furthermore, if you are attending an international mobility programme, you may substitute up to 3 specific replaceable Management/Economics courses - 18 ECTS. The substituting courses must pertain to the same scientific area of your undergraduate degree and there must not be significant overlap of content with other courses, either completed or to be completed.

### Is it possible to attend courses taught in English?

Yes, several courses in the undergraduate degree programmes in Economics and Management are taught in Portuguese and in English. Católica Porto Business School's effort to deliver teaching in English is in line with the expectations of the labour market. Thus, students will most likely have one or more courses taught in English per semester.

### How can I improve my grades?

All students are allowed to improve their grades:

- in the final examination in the resit examination period, in the academic year in which the course was successfully completed or in the following academic year. The examination has a weighting of 100%;
- by re-registering for the course in the academic year in which the latter was successfully completed or in the following academic year.

Students have a single opportunity to improve their grade, which means that the alternatives mentioned above are mutually exclusive. In the absence of a grade improvement, the first grade obtained prevails.

## What is the difference between being awarded ECTS credits for "equivalent courses", "free electives" and "substituting courses" completed under an international mobility programme"?

In the case of credits allocated to equivalent subjects, students attend a course outside Católica Porto Business School whose content is identical to that of a course included in their Study Plan. In this case, the course mentioned in the study plan and in the final certificate shall be the one offered by Católica Porto Business School. In the case of substituting courses, it is not required that the content of the substitute course and of the course offered by Católica Porto Business School to be substituted is the same. However, the substituting course must be from the same scientific area of the student's degree and there must not be any overlap of content with other courses completed or to be completed. When credits are awarded to a substituting or a free elective that is different from the one offered by Católica Porto Business School, the course that will be mentioned in students' study plan and in the final certificate will be the one that was indeed completed, together with the corresponding ECTS credits.

## How can I access the Special Assessment Period in September?

In order to have access to the Special Assessment Period you must comply with all the conditions laid down in the Regulations on Assessment.

Senior students:

- must have been awarded a minimum of 168 ECTS credits and fulfilled all the instrumental curricular requirements and have completed the additional curricular unit;
- may propose a number of final examinations corresponding to a maximum total of 12 ECTS credits that allows them to complete their undergraduate programme;
- must have been enrolled in the missing subject(s) at least once during their undergraduate degree programme (exceptions are provided for in the case of students under Mobility programmes - see Regulations);
- must register for the examinations to be held in the Special Period within the time-limit set for this purpose.

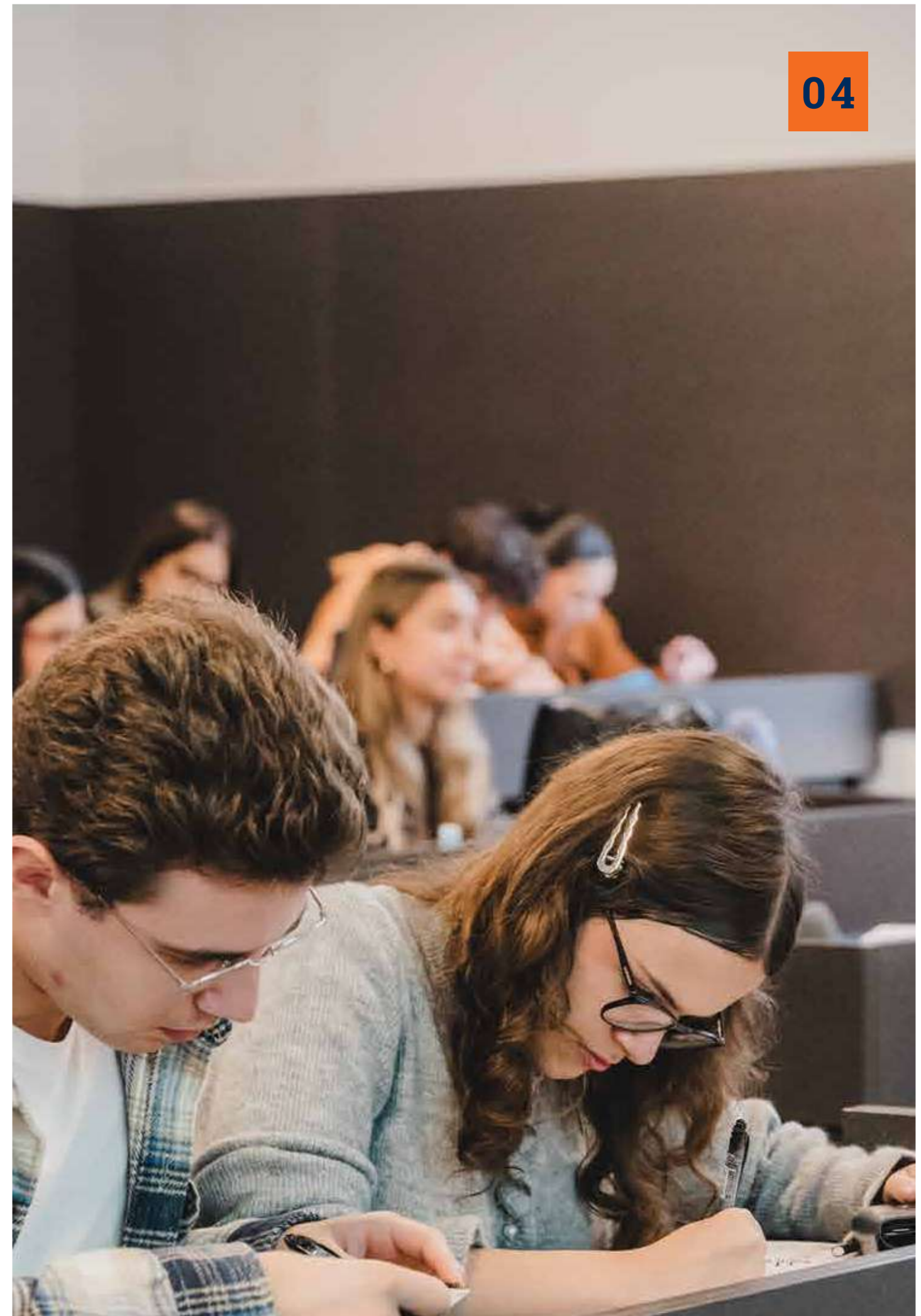
Students complying with the special conditions set out in chapter IV of the Regulations on Assessment:

- chronic and infectious diseases, death of a family member and hospitalisation;
- association leaders;
- student-Athletes;
- compliance with acts of public authority, childbirth and practitioners of religious faiths.

# Frequently Asked Questions

## Here you will find the best answers

Staying informed is the first step to make the most of all the tools that Católica Porto Business School puts at your disposal and to optimise your university experience.

### What are the tuition fees for the 2025-2026 academic year?

The monthly fees are set according to the number of ECTS credits corresponding to the courses in which students are enrolled in for the semester (minimum 18 ECTS). In each semester a payment corresponding to 5 monthly fees is due. If students follow the normal study plan \*1 semester = 30 ECTS.

[1] Applicants who are not offered a place in the 1st phase of the 1st application season will automatically reapply in the 2nd phase, without having to submit a new application or to pay any additional fees.

#### Other information:

- the amounts indicated above are subject to change in subsequent academic years;
- the application fee and the registration fee are non-refundable;

- the amounts shown correspond to predefined and indicative situations, and do not replace the knowledge of the Tuition and Fees Table;
- family benefits: UCP grants a reduction in the monthly tuition fees to families where two or more of their members are studying at the University (1st and 2nd cycle), live in the same household and depend on the same income, as provided for in the specific regulations. The second family member shall be awarded a 25% reduction and the third shall be entitled to a 50% reduction;
- the registration fee and the first monthly fee are due at the time of registration and will be refunded, in case of withdrawal, until the 2nd working day after the results of the national access contest are released.

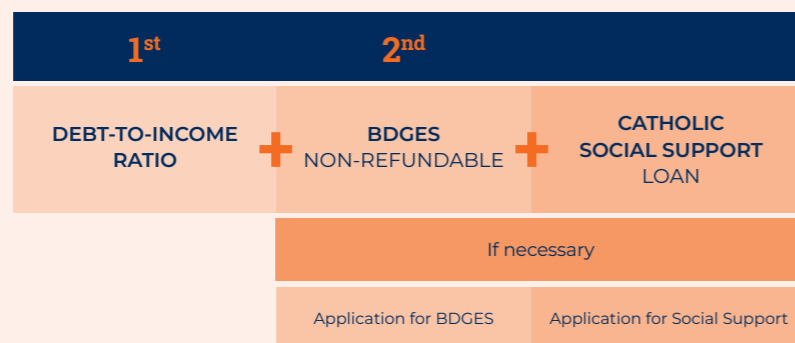
### How to pay for tuition fees?

Tuition fees are payable every month, by the 10th of each month, from September to June (10 months). When the time limit set out is not respected fines will be applied. Payment can be made in person at the Treasury or in an ATM machine (see references for payment in an ATM machine on the personal page of the virtual secretary - eSCA). If you are unable to pay, please notify the Treasury in due time.

## Is there funding for tuition fees?

## Do I need to register for examinations?

No registration is required in the normal assessment period. In the resit and special assessment periods registration is always required. Registration for the examinations to be held in the resit assessment period is made online no later than 3 working days before the date set for the examination.

Students who wish to register for the special assessment period are required to submit an electronic application during the month of July, on dates to be announced.

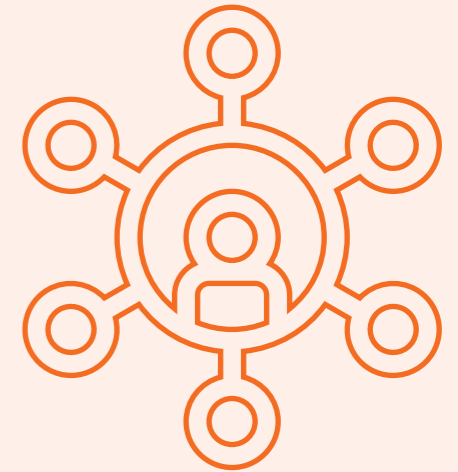
